### 4.2 Conditions for completing the course (evaluation criteria)

The condition for completing the course is:

- 1. Full participation and activity in exercises and seminars.
- 2. Full participation in lectures.

Exercises and seminars - the student's task is to conduct a subjective and physical examination of the patient, interpret the laboratory results, make the correct diagnosis and plan the therapeutic procedure as well as answer the questions about the issues raised at the seminars.

Assessment of skills during exercises:

5,0 - the student actively participates in the classes, is well prepared, knows and understands the causes, symptoms, principles of diagnosis and therapeutic management in the most common diseases in the practice of a family doctor, properly plans specialist consultations and keeps medical records.

4,5 - the student actively participates in the classes, knows and understands the causes, symptoms, principles of diagnosis and therapeutic management in the most common diseases in the practice of a family doctor, properly plans specialist consultations and keeps medical records.

4,0 - the student actively participates in classes, is corrected, knows and understands the causes, symptoms, principles of diagnosis and therapeutic management in the most common diseases in the practice of a family doctor, properly plans specialist consultations and keeps medical records.

PASS - FINAL TEST

• The test lasts 45 minutes from the start of writing the test, i.e. from the moment all students in the room took their place, the examiner presented the applicable rules, explained all doubts and answered all questions of students participating in the exam, the student representative confirmed with his signature that the students taking participation in the exam had the opportunity to familiarize themselves with the rules of the exam and obtained answers to all questions.

• The test consists of 60 questions with 1 correct answer.

• Range of grades: 2.0 - 5.0

5.0 - shows knowledge of the content of education at the level of 93% -100%

4.5 - shows knowledge of the content of education at the level of 85% -92%

4.0 - shows knowledge of the content of education at the level of 77% -84%

3.5 - shows knowledge of the content of education at the level of 69% -76%

3.0 - shows knowledge of the content of education at the level of 60% -68%

2.0 - shows knowledge of the content of education below 60%
