The competition is open to persons meeting the conditions set out in Article 113 of the Act of 20 July 2018. the Law on Higher Education and Science (i.e. Journal of Laws 2023, item 742 as amended).

### **MAIN RESPONSIBILITIES:**

- 1. Conducting scientific research in the discipline of literary studies under substantive supervision.
- 2. Teaching (lectures, practical classes, conversation classes, seminars),
- 3. Diploma thesis supervisor,
- 4. Cooperation with the socio-economic environment,
- 5. Carrying out tasks related to the University's research, teaching and organizational activities.

#### **REQUIREMENTS:**





- 1. Master's degree in English Philology or Applied Linguistics with English as the leading language;
- 2. Doctoral degree in the humanities in the discipline of literary studies, specialisation: British literature history;
- 3. At least one publication in a scientific journal with 70 points assigned by the Polish Ministry of Science and Higher Education;
- 4. Proficiency in English;
- 5. Proficency in Polish;
- 6. Documented participation in continuing education courses in didactics (Masters of Didactics);
- 7. Experience in teaching Practical English classes at the MA level in English Philology and/or Applied Linguistics departments;
- 8. Experience in conducting lectures and classes in the literatures of English-speaking countries in English Philology and/or Applied Linguistics departments;
- 9. Experience in supervising bachelor's theses (minimum 3 years) in the field of English Philology and/or Applied Linguistics (with English as the leading language);
- 10. Experience in reviewing bachelor's theses and/or master's theses in the field of English philology and/or Applied Linguistics (with English as the leading language);
- 11. Knowledge of modern IT techniques and tools;
- 12. Experience in conducting lectures for external audiences, such as participating in events like 'Night of English Studies' (Noc Anglistów), conducting open lectures, lectures for the University of the Third Age, etc.;
- 13. Experience in carrying out organizational tasks in a higher education institution, such as scheduling classes, working in the program team of a department, etc.

#### **IMPORTANT INFORMATION:**

As a prerequisite for the employment of the candidate selected in the open recruitment, the candidate must meet the requirements set out in Articles 113 and 118 of the Law on Higher Education and Science of 20 July 2018. (Journal of Laws of 2023, item 742, as amended), as well as the obligation under Article 265(5) and (13) of that Act.

When applying for employment at the University of Rzeszów as their primary place of work, candidates employed at other universities as their primary place of work should, on the date of employment, meet the condition set out in Article 120 of the Act of 20 July 2018. Law on Higher Education and Science (i.e. Journal of Laws 2023, item 742, as amended) according to which an academic teacher may have only one primary place of work at a time.

In the case of Non-Polish Candidates whose diplomas on awarding a professional degree/degree/academic title under Polish law require official recognition (nostrification), they cannot be employed until the recognition procedures are completed.

The competition procedure, pending its completion, may be interrupted or cancelled by the Rector, without giving any reason. The decision to employ a candidate is made by the Rector. In substantively justified cases, the Rector has the right not to employ a candidate selected in the competition procedure.

The results of the competition procedure shall not give rise to any claim by the candidates against UR, in particular a claim for employment. The selection board reserves the right to interview the candidates.

Recruitment committee has the right to conduct interviews with the candidates.





In accordance with Article 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27
