The competition may be entered by persons who meet the conditions specified in Art. 113 of the Act of July 20, 2018. Law on higher education and science (consolidated text: Journal of Laws of 2023, item 742, as amended).

MAIN OBLIGATIONS: (specific for a particular position)

- conducting and documenting teaching classes in the field of human physiology, mainly of a practical nature (seminars, exercises, laboratories, practical classes), including classes in English
- preparing training materials
- implementation of administrative tasks in accordance with scientific and teaching activities
- assistance in the organizational activities at the Department of Human Physiology and the Institute of Medical Sciences
- improving teaching or professional qualifications by participating in training and conferences
- participation in health promotion activities

REQUIREMENTS:

- Completed studies in biotechnology (preferred molecular biotechnology, analytical biotechnology or related)
- master's degree or equivalent
- qualifications and predispositions for teaching and scientific work (including molecular research)
- ability to work in a team
- fluent knowledge of English and Polish
- ability to use basic computer software (MS Office Suite)

ADDITIONAL REQUIREMENTS:

- experience in research on in vitro tissue and cell cultures
- documented scientific activity (publication, design)
- documented experience in presenting research results at scientific conferences
- experience in the practical use of molecular (including: qualitative and quantitative DNA/RNA analysis, PCR, qPCR, DNA microarrays) and biochemical (including: Western Blot, ELISA, MTT test, LDH test, Comet Assay, TUNEL, fluorimetric ROS determination; isolation of exogenous vesicles (exosomes)) techniques
- experience in laboratory and microbiological diagnostic techniques enabling, among others, implementation of practical laboratory exercises
- knowledge of training platforms: E-Physiology, PhysioEx
- knowledge of software: ArgusLAB, Avogadro, PyMOL, BioRender, GelQuantNET, Zotero, Mendeley Reference Manager
- knowledge of statistical analysis techniques, including proficiency in the use of Statistica and GraphPad PRISM programs

IMPORTANT INFORMATION:

A necessary condition for employing a candidate selected in an open recruitment process is their meeting the requirements determined in Art.113 and Art. 118 of the Law of 20 July, 2018 on Higher Education and Science (Journal of Laws 2023, item 472 as amended), and the obligation resulting from Art.265 paragraphs 5 and 13 of the Law.

If applying for employment at the University of Rzeszów as the primary place of employment,, candidates who are employed at any other university as the primary place of employment, shall comply with the condition defined in art.120 of the Law of 20 July, 2018 on Higher Education and Science (Journal of Laws 2023, item 742 as amended) according to which an academic teacher may hold only one position at a time referenced to as the primary place of employment.

In the case of candidates coming from abroad, whose diplomas of awarding professional title/academic degree/ scientific title require by Polish law an official recognition, they will not be employed until the recognition procedures have been finalized.

Until its deadline, the recruitment process may be ceased or annulled by the Rector without giving any justification. The decision to employ a candidate is made by the Rector. In justified cases, the Rector has the right not to employ the candidate selected in the recruitment process.

Recruitment results do not constitute grounds to raising any claims by the candidates against the UR, employment complaints, in particular.

Selection committee has the right to conduct an interview with the candidates.

According to Art.113 of the Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation), University of Rzeszów informs as follows:

5. Your personal data shall not be disclosed to third parties, except as provided for by law.
6. Your personal data will be stored for 12 months.
7. You have the right to request access to your personal data and the right to:
 - rectify it,
 - erase it,
 - limit its processing,
 - file an objection,
 - withdraw your consent at any given moment;
8. You have the right to file a complaint with a supervisory authority, the [Chairman of Poland's Personal Data Protection Office](#) if you consider that the processing of the personal data relating to you infringes the Regulation.
