The competition is open to persons who meet the conditions specified in art. 113 of the Act of 20 July 2018 - Law on Higher Education and Science (Journal of Laws 2024, item 1571).

MAIN DUTIES:

- conducting scientific research in the discipline of economics and finance,
- conducting classes with students in the field of economics and finance and accounting,
- preparing scientific articles for peer-reviewed journals,
- disseminating research results (participation in scientific conferences, science popularization activities),
- cooperation with the socio-economic environment,
- carrying out administrative tasks in accordance with scientific, teaching and organizational activities.

QUALIFICATION REQUIREMENTS:

- a PhD or postdoctoral degree in the field of social sciences in the discipline of finance, economics or economics and finance,
- several years of teaching experience at a university, including experience in promoting bachelor's and master's theses,
- scientific achievements in the discipline of economics and finance or related (documented by publications in peer-reviewed journals from the MNiSW list) from the last 5 years,
- knowledge of Polish: fluent in speech and writing (for foreigners),

- very good knowledge of English.

ADDITIONAL REQUIREMENTS:

- knowledge of statistical programs,
- practical experience (in the form of employment, internships, expert or media cooperation) in the area of finance, accounting or banking and insurance,
- optionally other confirming qualifications (completed courses, training).

EMPLOYMENT CONDITIONS:

- full-time employment based on a fixed-term employment contract,
- expected start date: February 17, 2025,
- employment at the University as the primary place of work,
- remuneration in accordance with the University of Rzeszów Employee Remuneration Regulations,
- opportunity for further professional development,

- group life insurance for University employees, their spouses/life partners and adult children.

IMPORTANT INFORMATION:

A necessary condition for employing a candidate selected in an open recruitment is that the candidate meets the requirements specified in art. 113 of the Law on Higher Education and Science of 20 July 2018 (Journal of Laws 2024, item 1571), as well as the obligation arising from art. 265 paragraphs 5 and 13 of this Act.

In the case of applying for employment at the University of Rzeszów as the primary place of work, candidates employed at other universities as the primary place of work should, on the day of employment, meet the condition specified in art. 120 of the Act of 20 July 2018. Law on Higher Education and Science (Journal of Laws 2024, item 1571), according to which an academic teacher can have only one primary place of work at a time.

In the case of Candidates from outside Poland whose diplomas awarding a professional title/academic degree/academic title require official recognition (nostrification) under Polish law, they cannot be employed until the recognition procedures are completed.

The competition process, until it is completed, may be interrupted or invalidated by the Rector, without giving a reason. The decision to employ a candidate is made by the Rector. In substantively justified cases, the Rector has the right not to employ a candidate selected in the competition process.

The results of the competition process do not constitute a basis for the Candidates to make any claims against UR, in particular a claim for employment.

The competition committee reserves the right to conduct an interview with the candidates.

In accordance with Article 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation), the University of Rzeszów informs:

1. The administrator of your personal data is the University of Rzeszów represented by the Rector with its registered office at Aleja Rejtana 16c, 35-959 Rzeszów.
2. The administrator of personal data has appointed a Data Protection Inspector supervising the correctness of personal data processing, who can be contacted via the e-mail address: iod@ur.edu.pl.
3. Your personal data will be processed for the purpose of conducting an open competition.
4. The basis for the processing of your personal data is the consent to the processing of personal data.

5. Providing data is voluntary, but necessary to achieve the purposes for which it was collected.
6. The data will not be made available to external entities, except in cases provided for by law.
7. The data will be stored for a period of 12 months.
8. You have the right to access the content of your data and the right to:
 - rectify,
 - delete,
 - limit processing,
 - object,
 - withdraw consent at any time;
9. You have the right to lodge a complaint with the President of the Personal Data Protection Office if you consider that the processing of your personal data violates the provisions of the general data protection regulation.
