

**ORDINANCE No. 120/2022
OF THE RECTOR
OF THE UNIVERSITY OF RZESZÓW
of September 20, 2022**

**on: the amount of the doctoral scholarship in the academic year 2022/2023
for doctoral students at the Doctoral School at the University of Rzeszów**

Pursuant to Article 23(1) in connection with Article 209(1), (1a), (2), (4)(1) and (2), (7) and (8) of the Act of July 20, 2018 – The Law on Higher Education and Science (i.e. Journal of Laws of 2022, item 574, as amended) I hereby order as follows:

§ 1

The amount of the monthly doctoral scholarship for doctoral students at the Doctoral School at the University of Rzeszów in the academic year 2022/2023, referred to in Article 209(4)(1) of the Act of July 20, 2018. – The Law on Higher Education and Science is PLN 2,371.70 subject to § 5.

§ 2

The amount of the monthly doctoral scholarship for doctoral students at the Doctoral School at the University of Rzeszów in the academic year 2022/2023, referred to in Article 209(4)(2) of the Act of July 20, 2018. - The Law on Higher Education and Science amounts to PLN 3,653.70 subject to § 5.

§ 3

The doctoral student at the Doctoral School at the University of Rzeszów in the academic year 2022/2023, in relation to whom no mid-term assessment has been carried out, having a certificate of disability, a certificate on the degree of disability or a certificate referred to in Article 5 and Article 62 of the Act of August 27, 1997 on vocational and social rehabilitation and employment of persons with disabilities, receives a doctoral scholarship in the amount of PLN 3,083.21 subject to § 5.

§ 4

The doctoral student at the Doctoral School at the University of Rzeszów in the academic year 2022/2023, in relation to whom a mid-term evaluation was carried out, having a certificate on disability, a certificate on the degree of disability or a certificate referred to in Article 5 and Article 62 of the Act of August 27, 1997 on vocational and social rehabilitation and employment of persons with disabilities, receives a doctoral scholarship in the amount of PLN 4,365.21 subject to § 5.

§ 5

1. A doctoral scholarship paid from external funds as part of scientific projects may be awarded to a doctoral student of the Doctoral School at the University of Rzeszów in an amount higher than that listed in § 1, §2, §3 and § 4.
2. The doctoral scholarship referred to in paragraph 1 may be awarded in the amount not exceeding the amount of financial resources allocated for this purpose in the cost estimate of a scientific project.
3. The amount of the doctoral scholarship referred to in paragraphs 1 and 2 shall be decided by the Rector of the University of Rzeszów.

§ 6

1. The doctoral student loses the right to the doctoral scholarship in the case of:
 - a) completion of education at the Doctoral School at the University of Rzeszów, except that the doctoral student who submitted his/her doctoral dissertation earlier than the date of completion of education provided for in the PhD program, receives a doctoral scholarship until the date of completion of his/her education, but not longer than for 6 months, subject to point b),
 - b) when the total period of receiving a doctoral scholarship in doctoral schools exceeds 4 years,
 - c) deletion from the list of doctoral students, subject to paragraph 2,
 - d) obtaining a doctoral degree not related to education at the Doctoral School at the University of Rzeszów, subject to paragraph 3,
 - e) receiving remuneration in the amount of at least 150% of the amount of the doctoral scholarship due in accordance with Article 209(4) of the Act of July 20, 2018 - The Law on Higher Education and Science, from employment related to the implementation of a research project referred to in Article 119(2)(2) and (3) of the aforementioned Act, by the institution running the doctoral school in which the doctoral student is educated, during this employment, subject to paragraph 4.
2. In the event of deletion from the list of doctoral students, the doctoral student loses the right to the doctoral scholarship on the day when the decision to delete the student becomes final. The doctoral scholarship is paid in proportion to the number of days on which the doctoral student had the status of doctoral student.
3. In the case of obtaining a doctoral degree not related to education at the Doctoral School at the University of Rzeszów, the doctoral student loses the right to the doctoral scholarship on the day when the decision to award the doctoral degree becomes final. The doctoral scholarship is paid in proportion to the number of days on which the doctoral student did not have a doctoral degree.
4. In the case of employment referred to in paragraph 1 point e), the doctoral scholarship shall be paid in proportion to the number of days on which the doctoral student was not employed.

§ 7

1. The doctoral scholarship is paid to the bank account provided by the doctoral student.
2. The payment of the doctoral scholarship is made by the last day of each month after the doctoral student has submitted a statement for the purposes of the Social Insurance Institution (ZUS).

§ 8

The Director of the Doctoral School at the University of Rzeszów is responsible for the implementation of the provisions of this ordinance.

§ 9

The ordinance enters into force on October 1, 2022.
