The doctoral seminar is aimed at preparing the doctoral student to undertake creative work independently, independent artistic creation, and to formulate a topic and an individual area of artistic research. During the course of the class, the doctoral student deepens his/her knowledge of the subject under study by implementing an Individual Research Plan. The doctoral student develops his workshop skills to skillfully formulate his own concept. The deepening of knowledge in various fields of art is aimed at preparing the doctoral student to undertake independent creative activities so that his/her own artistic expression brings new values.

### **COURSE CONTENT**

Analysis and observation of previous artistic achievements and preliminary concept. Determination of the area, in the direction of the activities of artistic exploration of scientific technical and technological possibilities that enable the creative development of the doctoral student. Discussions on how to act within the framework of the realized own artistic concept and theoretical and its motivation. Looking at artistic achievements during the creative process. Stimulating and encouraging presentations at exhibitions. Working on the text of the self-presentation. Theoretical basis for the creation of an Individual Research Plan. Work on the text of the self-reference in connection with artistic achievements. Preparation of the dissertation, exposition and defense.

#### semester I

Topic: Collaborative analysis of past artistic achievements/your own work.

Topic: Presentation of initial concept and intentions.

Topic: Exploration within the topic/issue based on literature.

Topic: Discussion of the message.

# semester II

Topic: Clarification of one's own field of interest and research area.

Topic: Theoretical motivation of own research conducted.

Topic : Exhibitions and competitions. Opportunities for confrontation and presentation of one's own artistic achievements.

Topic: Joint analysis of past achievements in the context of the works of contemporary artists.

Topic: Defining and specifying the Individual Research Plan. Joint analysis.

#### semester III

Topic: Critical analysis of contemporary art and especially printmaking on the basis of current exhibitions, art events catalogs, curatorial texts.

Topic : The condition of contemporary art. Current phenomena, latest trends, the Venice Art Biennale exhibition.

Theme: Graphic arts in the world. The largest exhibitions.

Topic: Graphic arts related to other fields of art.

Topic: The concept of printmaking understood in an open way.

#### semester IV

Topic : Discussing the results of the doctoral student's research in the context of the concept of the whole.

Topic: Following the creative process and its development.

Topic: Discussing decisions and possible changes resulting from the ongoing and developing creative process during the work.

Topic : Self-reference - the part of the work closely related to artistic activities and its theoretical grounding.

# semester V

Theme: Multimedia, space, interdisciplinary activities-examples of works by selected artists.

Topic: Traditional graphic design workshop and its place in contemporary graphic design.

Topic: Analysis of the concept proposed by the doctoral student in the context of phenomena in contemporary art.

### semester VI

Topic: Graphic values in the works of selected artists.

Topic: Graphic artists, exceptionally important for the development of the field.

Topic: Development of printmaking in the last 60 years, International Triennial of printmaking.

#### semester VII

Topic: Text read in the context of the visual part. Topic: Discussion on the final shape of the work.

Topic: Preparation of the presentation and joint search for a suitable exhibition space.

Topic: Preparation of the thesis and defense.

#### **COURSE ASSESSMENT CRITERIA**

The evaluation is based on the continuous work of the doctoral student in each semester and academic year in terms of: implementation of research, expansion of knowledge, study of literature, involvement and progress in the preparation of the dissertation. Possible semester grades are: 2.0, 3.0, 3.5, 4.0, 4.5, 5.0.

Percentage requirements for the grading scale:

In order to obtain a passing grade, the conversion factor for the corresponding percentage of points obtained is applied:

- up to 50% insufficient, (the doctoral student does not make progress in scientific research, does not expand his knowledge, does not study the readings, does not participate in substantive discussion, does not fulfill his scientific duties);
- 51% 60% sufficient, (the doctoral student makes negligible progress in scientific research, expands knowledge, studies primary literature, the discussion held is limited to a narrow range of substantive knowledge, fulfills basic scientific duties);
- 61% 70% sufficient plus, (the doctoral student makes progress in scientific research, expands knowledge, studies basic literature, substantively participates in discussion, fulfills scientific duties);
- 71% 80% good, (the doctoral student makes significant progress in scientific research, expands knowledge, studies primary and secondary literature, substantively participates in discussion, fulfills all scientific duties);
- 81% 90% good plus, (the doctoral student makes significant progress in scientific research, systematically expands knowledge, studies primary and supplementary literature, substantively participates in discussion, fulfills all scientific duties);
- 91% 100% very good (the doctoral student makes significant progress in scientific research, systematically expands knowledge, studies basic, complementary and beyond the obligatory literature, substantively participates in discussion, fulfills all scientific duties).
