BRIEF DESCRIPTION OF COURSE

The aim of the seminar is to prepare the student for:

- a) conducting research formulating a research problem and hypotheses, defining the theoretical framework for research, selecting research methods, techniques and tools, research planning. The seminar also aims to provide skills in the field of source inquiry, analysis of existing research results, documents and literature on the topic, as well as techniques and tools of empirical research. The seminar also helps the PhD student observe ethical principles in academic research, as well as develop a critical attitude towards the already existing research results and the results of her/his own research;
- b) writing research papers providing knowledge about structure and principles of academic papers including the principles of observing copyrights and other rights;
- c) preparing and delivering of conference presentations with the use of multimedia;
- d) writing research projects and applying for research grants;
- e) writing a PhD dissertation and its defence;
- f) conducting classes at a university, including preparing a course syllabus, selection of literature for students, the use of various teaching methods;
- g) participation in academic life, including participation and organization of scientific meetings and research groups.

## **COURSE ASSESSMENT CRITERIA**

Semester I: defining the research problem and research goal; initial collection of literature and source materials. Semester II: determining the theoretical framework and research methodology; delimitation of research field; formulating the dissertation title, hypotheses and research questions; elaborating of a research plan broken down into stages; collection of source materials.

Semester III: data collection on the basis of existing sources; elaborating of the dissertation theoretical chapter, writing a conference paper and a journal article based on the results of own research.

IV semester: elaborating of empirical research (plan, techniques and tools); participation in a scientific conference; writing and submitting a journal article; elaborating the research project with possible application to the NSC; progress in writing the dissertation.

Semester V: carrying out an empirical research; participation in a scientific conference; preparing and submitting a journal article; progress in writing the dissertation.

Semester VI: analysis the results of an empirical research; participation in a scientific conference and submitting a journal article; progress in writing the dissertation.

Semester VII: participation in a scientific conference and submitting a journal article; preparing a draft version of dissertation.

Semester VIII: completing the dissertation and its submission.
