# Regulation No. 138/2020 Rector of the University of Rzeszów of December 9, 2020 amending Ordinance No. 73/2020 of the Rector of the University of Rzeszów of June 26, 2020 on the organization of the academic year 2020/2021

Based on Article. 23 sec. 2 of the Act of July 20, 2018 Law on Higher Education and Science (ie Journal of Laws of 2020, item 85, as amended) in connection with § 19 para. 2 of the Regulations of Studies at the University of Rzeszów, attached to Resolution No. 555/04/2020 of the Senate of the University of Rzeszów of 23 May 2020 and § 5 sec. 1 of the Regulation No. 73/2020 of the Rector of the University of Rzeszów of June 26, 2020 on the organization of the academic year 2020/2021, the following is amended:

#### **§**1

In the Regulation No. 73/2020 of the Rector of the University of Rzeszów of June 26, 2020 on the organization of the academic year 2020/2021, the following changes are introduced: 1.in § 1 sec. 1 part concerning the organization of the winter semester is replaced by the following:

- 2. in § 1 sec. 4 is replaced by the following:
- "4. In the case of classes falling on non-working days (11/11/2020, 23/12/2020, 03/05/2021, 03/06/2021), the dean of the college, with the consent of the teaching board, determines the manner of their implementation according to an individual schedule:
- 1) within the time limits provided for the classes referred to in § 1 it. 1, or
- 2) by extending the deadline for completing classes in the manner referred to in para. 3, or
- 3) with the use of distance learning methods and techniques (ie in a remote form), unless the overriding regulations state otherwise. "
- 3. in § 2 sec. 1 part concerning the detailed list of weeks of classes in full-time studies in the winter semester in the academic year 2020/2021 is replaced by the following:

# 5. § 5 sec. 3 is replaced by the following:

"3. In the cases referred to in para. 1-2, subject to § 1 section 3 of this ordinance, the change in the organization of individual parts of the academic year takes place with the consent of the Rector of the University of Rzeszów after the opinion of the Student Self-Government of the University of Rzeszów.

### § 2

Other provisions of Ordinance No. 73/2020 Rector of the University of Rzeszów dated 26 June 2020. On the organization of the academic year 2020/2021 remain unchanged.

## § 3

- 1. I entrust the supervision over the implementation of this ordinance to the Vice-Rector for Student Affairs and Education.
