

**Regulation No. 86/2020 of the Rector of the University of Rzeszów on August 11, 2020 amending Regulation No. 61/2020 of the Rector of the University of Rzeszów on May 29, 2020 on changes in the organization of the 2019/2020 academic year at the University of Rzeszów and establishing detailed rules for the end of the 2019/2020 summer semester**

Based on Article. 79 sec. 7 of the Act of April 16, 2020 on special support instruments in connection with the spread of the SARS-CoV-2 virus (Journal of Laws of 2020, item 695, as amended) and Art. 23 sec. 2 and art. 76a of the Act of July 20, 2018 Law on Higher Education and Science (i.e. Journal of Laws of 2020, item 85 as amended) in connection with the Regulation of the Minister of Science and Higher Education of May 21, 2020 on the temporary limitation of the functioning of certain entities of the higher education and science system in connection with the prevention, counteraction and combating COVID-19 (Journal of Laws of 2020, item 911) and § 19 para. 2 of the Regulations of Study at the University of Rzeszów, attached to Resolution No. 450/05/2019 of the Senate of the University of Rzeszów of 30 May 2019, I manage the following:

**§ 1**

In the Regulation No. 61/2020 of the Rector of the University of Rzeszów of May 29, 2020. on changes in the organization of the 2019/2020 academic year at the University of Rzeszów and on establishing detailed rules for the end of the 2019/2020 summer semester, the following changes are introduced:

1) in § 4 after section 10, section 11 is added to read as follows: "11. In exceptional cases, upon a justified request of the college dean, the Rector may consent to the conduct of a credit or an exam in the resit examination session by direct contact (irrespective of the field of study), subject to the sanitary regime."

2) in § 7, subpara. 5, the following section 6 is added: "6. Transferring the student to the next (higher) semester in the 2020/2021 academic year in the event of failure to complete and complete the classes or internships for reasons beyond the control of the student and the University due to the prevention of the spread of SARS-CoV-2 virus in the 2019/2020 academic year, in particular, referred to in § 3, is not a decision on conditional enrollment for the next semester or repeating classes due to unsatisfactory academic results, referred to in the Regulations of Studies at the University of Rzeszów and is not the basis for calculating fees on this account. It is allowed to arrange an individual student organization of studies on the principles set out in the Regulations of Studies at the University of Rzeszów."

**§ 2**

Other provisions of the Regulation No. 61/2020 of the Rector of the University of Rzeszów on May 29, 2020. on changes in the organization of the 2019/2020 academic year at the University of Rzeszów and on the detailed rules for the end of the 2019/2020 summer semester remain unchanged.

**§ 3**

Supervision over the implementation of this Ordinance is entrusted to the Vice-Rector for Student Affairs and Education.

**§ 4**

The Ordinance enters into force on the day of signing.
