

Elżbieta Feret, Prof. Head of the Financial Law Department, Institute of Legal Sciences. University of Rzeszow. Attorney-at-law, specialist in public finance. She was the Dean of the Faculty of Law and Administration of the University of Rzeszów; the Director of the Institute of Legal Sciences of the University of Rzeszów; the Vice-Rector of the College of Social Sciences of the University of Rzeszów. Thematic areas of conducted research: 1. financial and legal aspects of the functioning of public finance sector units with particular emphasis on the local government level in Poland; 2. genesis and influence of Polish and foreign concepts and theories of self-government on the financial aspects of the operation of the local government level; 3. analysis of common administrative and financial aspects of the activities of units of local government, taking into account the specificity of municipal management; 4. ensuring the financial security of the activities of local government units, taking into account the financial authority of the state, however, with an indication of constitutional guarantees for the implementation of local government public tasks. As part of her didactic activity, she has conducted classes in the field of financial law, including: Public Finance Law, Local Government Public Finance, Tax Law and Procedure, Public Banking Law, Customs Law, Foreign Exchange Law and EU Funds. Within the Erasmus and Erasmus + Programs, she conducted classes with students and doctoral students abroad; she also completed scientific internships abroad. She was the supervisor of the Scientific Students' Club of Financial and Tax Law. Within the organizational activity, she organized the exchange of academic teachers under the Leonardo da Vinci, Erasmus and Erasmus + Programs; organized a Summer School for Ukrainian journalists and students from Germany; participated in the Human Capital Operational Program "Legality, efficiency and good administrative practice as a condition for good governance" and in the Ministerial Project "Dialogue". She organized and actively participated in seminars, webinars and national and international scientific conferences; in 2022, she organized the Congress of Financial Law Departments in Rzeszów. She prepared the Forum of German and Polish Universities of Administration Student seminar "Administrative challenges related to persons from Ukraine under temporary protection" in July 1st – 6th 2024, in the grant "Migrants from Ukrainein the Podkarpackie Voivodeship. Socio-economic implications". She is a member of the scientific committees of Polish and foreign magazines, including: the quarterly "Prawo budżetowe Państwa i Samorządu"; "Ius et Administratio", Scientific Journal of the University of Rzeszów "Acta Iuridica Resoviensia", "Revista Facultății de Drept Oradea Journal of the Faculty of Law Oradea", "Rivista European Journal of Privacy Law & Technologies".
