RULES AND REGULATIONS OF THE "WELCOME CENTER UR PHOTO CONTEST"

§1

GENERAL PROVISIONS

- The "Welcome Center UR Photo Contest" (hereinafter referred to as the "Contest") is organized in the territory of the Republic of Poland by the University of Rzeszów, Rejtana 16C Ave., 35-959 Rzeszów (hereinafter referred to as "Organizer").
- 2. The contest will be held on the Facebook profile of Welcome Center UR, available at https://www.facebook.com/profile.php?id=61557075233101
- 3. The contest is not created, administered or sponsored by the Facebook social networking site. Facebook is a registered trademark of Meta, Inc. The Organizers is the only responsible party for any disputes arising as a result of the contest.

§2

PARTICIPANTS OF THE CONTEST

- 1. Only people who:
 - a. on the day of the start of the competition, have the status of a student of the University of Rzeszów;
 - b. are foreigners.
- 2. The participant declares that:
 - a. he/she has read the content of these Regulations and voluntarily enters the Contest;
 - agrees to and accepts the terms and conditions of these Regulations, including having read the content regarding the prize collection procedure and fully accepts it;
 - c. he/she undertakes to comply with the provisions of the Regulations, including Facebook's regulations;
 - d. consented to the processing of personal data (name, surname, e-mail address) for the purposes related to participation in the Contest;
 - e. Is a registered user of the Facebook social networking site.
- 3. The following people cannot take part in the Contest:
 - a. employees of the Organizer and other people involved in organizing the Contest;
 - b. persons closest to the persons mentioned in point a, i.e. spouses, ascendants, descendants, siblings, relatives in the same line or degree, persons remaining in the relationship of adoption or cohabitation.
- 4. Participation in the Contest is free of charge and voluntary.

DURATION OF THE CONTEST

The contest is run from May 27, 2024 to June 2, 2024, 11:59 p.m. (hereinafter referred to as the "Contest Duration").

§4

CONTEST JURY

- In order to ensure the proper organization and run of the Contest, and in particular to
 assess the correctness of applications to the Contest and to select the winners, the
 Organizer will appoint a Contest Committee (hereinafter referred to as the "Contest
 Committee").
- 2. The Contest Committee will consist of Vice-Rector for Student Affairs and Education and two representatives of Welcome Center of the University of Rzeszow.
- 3. Decisions made by the Contest Committee are final and not subject to appeal.

§5

AWARDS

- 1. The Contest includes prizes for two selected pieces of work. The prize is 1 (in words: one) reduced price ticket for KultURalia 2024. Total number of prizes: 2 (two).
- 2. Contest Participants are not entitled to claim payment of the value of the Prizes in cash or exchange the awarded Prize for another Prize.

§6

CONTEST COURSE

- 1. The contest task consists of:
 - a. posting a photo about "Study in Rzeszów" in a comment to the contest post on Facebook;
 - b. Using the hashtag #UniwersytetRzeszowski in this comment.
- 2. Applications that do not meet the above requirements will not be taken into account.
- 3. The contest jury will select from among the works that meet the following points: 1 and 2 works according to the following criteria:
 - a. relevance to the topic;
 - b. ingenuity and creativity in the interpretation of the Contest theme;
 - c. overall artistic impression.

ANNOUNCEMENT OF RESULTS

- 1. The results of the Contest will be announced no later than June 4, 2024 on the Facebook profile of the Welcome Center UR.
- 2. The winners will be notified via private message on Facebook.
- 3. The winner is obliged to confirm receipt of the message and provide his/her details (name, surname, UR ID number) within 2 days from receiving the message.
- 4. If the winner does not respond within the appointed time, the Prize is transferred to the next person.

§8

PROCESSING OF PERSONAL DATA

- 1. The Organizer is the administrator of personal data provided by the Contest Participants.
- 2. Personal data will be processed only for the purpose of conducting the Contest and issuing the prizes.
- 3. Personal data of the Contest Participants will be stored for the period necessary for conducting the Contest and issuing the prizes.
- 4. Participants have the right to view, correct and delete their personal data.

§9

FINAL PROVISIONS

- 1. The Organizer keeps the right to change the rules of the Contest, including the content of these regulations, during the Contest period.
- 2. The Organizer declares that the Contest is in no way sponsored, supported or conducted by Facebook or associated with it.
- 3. Any doubts regarding the Contest and the provisions of these regulations will be resolved by the Organizer.
