I hereby declare that:

1. I have scientific/artistic* achievements related to research problems undertaken by the above-mentioned doctoral student.
2. I am¹:

3. Over the last 5 years I have not supervised:

 - 2) at least 2 applicants for the doctoral degree who did not receive positive reviews from at least 2 reviewers.
4. I have the title of professor/the degree of habilitated doctor/not applicable*.
5. I do not have the title of professor or the degree of habilitated doctor. I am an employee of a foreign university or scientific institution²/not applicable*.
6. There is no conflict of interest between the above-mentioned doctoral student and me.

 - 1) we do not have a common household;

¹ The appointment of a supervisor employed outside of the University of Rzeszów is possible if the University of Rzeszów does not employ a person with scientific or artistic achievements related to research problems undertaken by the doctoral student.

² The supervisor may be a person who does not have the title of professor or the degree of habilitated doctor, but is an employee of a foreign university or scientific institution, if the body of University of Rzeszów for the conferral of a scientific degree or a degree in the field of arts recognizes that this person has significant achievements related to scientific issues covered by the doctoral dissertation.

- 2) we do not have a relationship of kinship, affinity up to the second degree, or a relationship of adoption, custody or guardianship.
7. During the education of the above-mentioned doctoral student at the Doctoral School at the University of Rzeszów, I commit myself to provide proper substantive supervision for the doctoral student including:
 - 1) control over the implementation of the Individual Research Plan in accordance with the PQF level 8;
 - 2) substantive support in applying for intra-university and extra-university grants by the doctoral student;
 - 3) delegating and preparing the doctoral student to participate in a minimum of one international conference and a minimum of one national conference;
 - 4) support in establishing contacts with other academics – authorities on the subject matter of the doctoral dissertation;
 - 5) substantive support in the preparation of scholarship applications under domestic or foreign programs;
 - 6) conducting the classes included in the curriculum of the UR Doctoral School in accordance with the learning outcomes specified for the course/subject.
