<p>To pass the course, students must:</p> <ul style="list-style-type: none"> - Obtain at least 60% on the final test. The test consists of 20 multiple-choice questions and covers topics discussed during the lecture. - Submit a self-written essay (1500 words), in which students are required to demonstrate a deep understanding of key events, trends, theories, and concepts in international relations since 1945. They must also apply appropriate historical, theoretical, and empirical knowledge to analyze contemporary issues and global challenges. The essay is evaluated based on its substantive content (reference to lecture topics), as well as its linguistic and stylistic quality.
