REQUIREMENTS FOR ABSTRACTS

1. Abstracts that have not been published before are accepted for publication. Number of authors - no more than 3.

2. The volume of abstracts of the scientific report is 2-3 full A4 pages (297 × 210 mm) (including references) on letters in the MS Word editor, book orientation.

3. Page numbering is not affixed, hyphens in the text are not allowed.

4. Text: margins on all sides - 2 cm, paragraph indent - 1.0 cm; font: typeface - Times New Roman, size - 14 pt., line spacing - 1 ;. aligned in width; style - Normal.

5. Abstracts structure:

author's name and surname – in the right corner (Times New Roman, 14 pt., bold);

scientific degree and academic title of the author – in the next line on the right (Times New Roman, 12 pt, italics);

official capacity, full name of the organization where the author works (studies), country - lower right (Times New Roman, 12 pt, italics);

Abstracts title – across the line, in the center, in capital letters (Times New Roman, 14 pt., bold).

Text structure: introduction; formulation of the problem; results of the research; conclusions.

6. **References** – 1 interval after the text of the abstracts of the report in the original language in accordance with the established DSTU 8302: 2015 bibliographic requirements. References cited should be numbered according to the order of mention in the text. References are given in square brackets. Title to the list of used sources – **Literature** (font Times New Roman, - 14, bold, italics).

7. Do not place tables and graphs in the text of abstracts, do not use hyperlinks.

The abstracts of the reports are published in the author's edition. The Organizing Committee reserves the right to reject materials that do not meet the requirements for registration, the theme of the conference or received late.
